TERMS AND CONDITIONS

1. The Subscriber will purchase the Programme: Industrial Gases – Business Performance Analysis for the subscription period of one year in accordance to the following terms and conditions.

4. The period of consulting time allowed under the terms of this subscription to the Programme is one hour a quarter – by telephone or other electronic means. Should the Subscriber wish to use or have more time then Spiritus and its consultants may provide additional advice or information under a separate professional fee and expense basis.
